Job Description

The Junction Creek Stewardship Committee is seeking an organized, reliable, and hardworking individual to coordinate ecological restoration activities while facilitating research, monitoring, and stewardship projects in the Junction Creek watershed. The Stream Restoration & Stewardship Intern will work under the direction of the Executive Director and Board of Directors to coordinate stream and riparian restoration activities, deliver programs, write reports and communicate results. The work will assist in the rehabilitation and conservation of the Junction Creek watershed in Greater Sudbury, Ontario.

Eligibility Requirements

Meet the following wage subsidy internship eligibility requirements:

- University or college graduate who has graduated within the last 3 years from an accredited college or university;
- The position must be a first full-time employment in the candidate's field of study; and
- Candidates must be legally entitled to work in Canada.

Responsibilities

- Coordinate and conduct restoration and stewardship activities such as riparian revitalizations, garbage clean-ups, planting native vegetation, and invasive species management with local organizations and volunteer groups.
- Assist with stream monitoring programs by participating in biomonitoring, water quality surveys, and various other research projects.
- Maintain organized and detailed records (notes, photographs, etc.) to track progress of restoration projects.
- Enter and manage data related to research, restoration, and monitoring activities; summarize and share results through written reports, presentations to stakeholders, and social media posts.
- Assist with equipment maintenance, cleaning and organization.
- Support collaboration with community partners and the general public; assist with managing and coordinating volunteers.
- Participate in outreach programs, events/festivals, and other programs to educate the public.

Qualifications and skills

- A post-secondary degree or diploma in Environmental Restoration/Monitoring, Fish and Wildlife Technician, Science Communication Program, Biology or other related field of study.
- Excellent computer skills (Microsoft Excel, Word, Power Point, etc.)
